# Rules

## Council Rules

No one is to ride in the boat while going up or down the slip.

Only Boat/Crew and Lady/personal members of FBAC with full drivers licence and who have received tractor-driving instruction are allowed to drive the tractors.

No person to be carried as passengers on the tractors.

## Launching Rules

All boat owners using the launching facilities of the Fylde Boat Angling Club must be members of the boat membership scheme and display the current years membership badge on the boat. All boat trailers must have FBAC and the boat name on them. The scheme entitles the boat owner to use the club tractors for launching and retrieval. It is the boat member's responsibility to ensure their boat is trailed safely and secured at all times and the Boat and trailer are serviceable.

All children to wear Lifejackets.

Single boat launches MUST have 2 club members eligible to drive the tractors.

New Members must wait for committee approval before being eligible for Single boat launch.

2 Tractors both with ropes must be running at all launches and retrieves.

No single boat to be out in the hours of darkness.

Tractors not to be taken any deeper than the rim of the rear tyre, this includes crossing gullies.

No boat must leave the shore unless under its power.

Membership of the FBAC entitles you to the use of club facilities including the club house, tractors and match/shore fishing. It is strongly recommended that all crew join as personal members to allow single boat launching access to the tractors and insurance.

Non- members may use the facilities ONLY 3 times.

Infringement of the rules will lead to 1. Verbal warning 2 written warning 3 before the committee

Gross misconduct is liable to instant dismissal.

## Member declaration

I declare that I consider the boat detailed is safe and seaworthy, and carries all the safety equipment detailed within the current RNLi Sea Check Scheme. I also confirm that I will keep the boat insurance valid for the period of the membership. I agree to abide by all the club rules and declare that to the best of my knowledge I am sufficiently physically and mentally fit to launch and retrieve boats, and hold a current full UK driving licence to enable me to drive the tractors **AFTER TRAINING**. I agree that in no event shall I hold Fylde Boat Angling Club nor its committee and or members to be liable for any incidental, indirect, or consequential damages whatsoever ( including, without limitation, damages for loss of business profits, business interruption, loss of earnings, or any other pecuniary loss) arising out of the use of or inability to use the facilities of the clubhouse, boat house, slipway and any other equipment there in, even if the Fylde Boat Angling Club has been advised of the possibility of such damages.
